of

We, the undersigned, whose names are hereunto subscribed, make this certificate for the purpose of forming a corporation to be known as the Pharmaceutical Research Institute of America, Inc., and hereby associate ourselves together for the purpose of becoming such corporation for profit under the laws of the State of Florida for the purpose and with the rights, powers and objects hereinafter set forth, as follows:

Article I

The name of the corporation shall be Pharmaceutical Research Institute of America, Inc.

Article II

To engage in any activity of business permitted under the laws of the United States and the State of Florida; except that it is not to conduct banking, sale deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone, or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.

Article III

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is TWO HUNDRED FIFTY (250) shares of non-par value stock.

Article IV

The amount of capital with which this corporation will begin business is FIVE HUNDRED DOLLARS (\$500.00).

Article V

This corporation is to exist perpetually.

Article VI

The initial post office address of the principal office of this corporation in the State of Florida is 4647 Glenside Circle Tampa, FL 33624. The Board of Directors may from time to time move the principal office to any other address in Florida.

Article VII

This corporation shall have (1) Directors, initially. The number of Directors may be increased or diminished from time to time, by By-laws adopted by the Stockholders but shall never be less than one (1).
