**ARTICLE I - Name of corporation :**



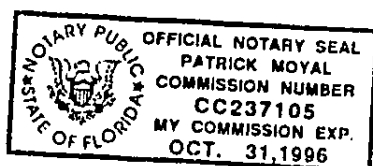


