The undersigned Incorporator, GEORGE C. CARR, for the purpose of forming a professional service corporation for the practice of law under the provisions of Chapter 621, Florida Statutes, the "Professional Service Corporation Act", hereby adopts the following Articles of Incorporation.

**ARTICLE I
NAME**

The name of the corporation shall be GEORGE C. CARR, P.A.

**ARTICLE II
PURPOSE**

The corporation is organized for the purpose of engaging in the practice of law. The professional services involved in the practice of law by the corporation may be rendered only through officers, agents and employees of the corporation who are duly authorized and licensed to provide such services in the State of Florida.

The corporation shall not engage in any business other than the practice of law. However, the corporation may invest its funds in real estate and in other types of investments and may own real and personal property necessary for the rendering of such services.

**ARTICLE III
PRINCIPAL OFFICE**

The principal place of business and mailing address of the corporation shall be 504 North Baylen Street, Pensacola, Florida, 32501.

**ARTICLE IV
TERM OF EXISTENCE**

This corporation is to exist perpetually.

**ARTICLE V
CAPITAL STOCK**

The corporation is authorized to issue 7,500 shares of \$1.00 par value common stock. The stock of the corporation shall be issued only to and may be transferred only to persons who are duly licensed to practice law in the State of Florida.

**ARTICLE VI
INITIAL REGISTERED AGENT AND ADDRESS**

The initial registered agent of the corporation is George C. Carr, 504 North Baylen Street, Pensacola, Florida, 32501.

**ARTICLE VII
INCORPORATOR**

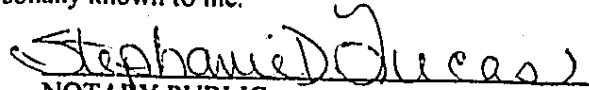

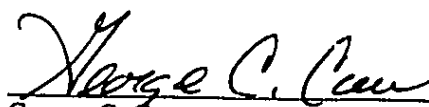
