## ARTICLES OF INCORPORATION OF

LAURETTA F. HAJIK , INC.

SECREMASSEE, FLORIDA SECREMASSEE, FLORIDA

The undersigned incorporator, for the purpose of forming a corporation in accordance with the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE J. NAME
