The undersigned subscribers to these Articles of Color Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

### ARTICLE I. NAME

The name of this corporation is ROE CONSTRUCTION, INC.

ARTICLE II. NATURE OF CORPORATE BUSINESS
