The undersigned, acting as sole incorporator, desiring to form a corporation for profit and pursuant to the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be First Class Painting, Inc.
