ARTICLE I. NAME

The name of this corporation is KEYSKIN MANUFACTURING, INC. (the "Corporation").

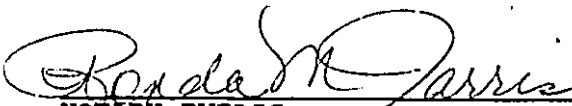

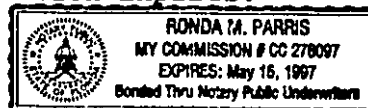
