**ARTICLES OF INCORPORATION  
OF  
M & T PRINTERS, INC.**

The undersigned, for the purpose of forming a corporation under the FLORIDA GENERAL CORPORATION ACT, hereby adopts the following Articles of Incorporation:

**ARTICLE 1 - NAME AND ADDRESS**

The name and address of this corporation is **M & T PRINTERS, INC.**, located at 308 North Orange Street, New Smyrna Beach, Florida 32168.

**ARTICLE 2 - DURATION**

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

**ARTICLE 3 - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE 4 - CAPITAL STOCK**

This corporation is authorized to issue 1000 shares of \$1.00 par value common stock which shall be designated "Common Stock".

**ARTICLE 5 - PRE-EMPTIVE RIGHTS**

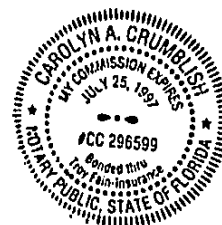
