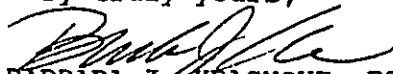

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation:

**ARTICLE I
NAME AND MAILING ADDRESS**

The name of the Corporation is FEDERAL MOBIL II, INC.

**ARTICLE II
TERM OF EXISTENCE**

The street address of the initial registered office in the State of Florida shall be 901 Commercial Blvd. Fort Lauderdale, Florida 33309.

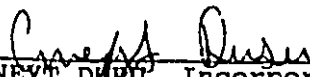

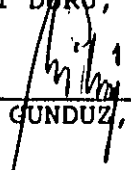
**ARTICLE VI
