The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of this corporation is Paging USA, Inc.

EFFECTIVE DATE

MAR 28 1995

ARTICLE II

Duration

This corporation shall exist perpetually, commencing on March 28, 1995.

ARTICLE III

Nature of Business

This corporation is organized for the purpose of transaction of any or all lawful business.

ARTICLE IV

Capital Stock

This corporation is authorized to issue five hundred (500) shares of \$1.00 par value common stock, which shall be designated "Common Shares." Common Shares shall be issued pursuant to the direction of the Board of Directors, who shall designate such shares as either "voting" (in which case, such shares shall have the full range of voting rights under applicable law) or "nonvoting" (in which case, such shares shall have no voting rights, for any purpose) at the time of issuance. "Voting" and "nonvoting" Common Shares shall be identical in all respects except for the foregoing difference in voting rights. The legend "voting" or "nonvoting," as applicable, shall be prominently affixed to the face of all stock certificates issued to holders of Common Shares.

## ARTICLE V

### Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 200 West Forsyth Street, Suite 1100, Jacksonville, Florida 32202-4308, and the name of the initial registered agent of this corporation at that address is Michael A. Candeto.

## ARTICLE VI

### Directors

This corporation shall have three (3) directors initially. The number of directors may be increased or diminished from time to time by amendment of the Bylaws, but shall never be fewer than one (1).

### Bylaws

The initial Bylaws of this corporation shall be adopted by the directors. ## ARTICLE X

### Restrictions on Transfer of Stock

The shareholders may, by Bylaw provision or by shareholders' agreement, recorded in the minute book, impose such restrictions on the sale, transfer or encumbrance of the stock of this corporation as they may see fit.

## ARTICLE XI

### Director Compensation

The Board of Directors is hereby specifically authorized to make provisions for reasonable compensation to its members for their services as directors, and to fix the basis and conditions upon which such compensation shall be paid. Any director of the corporation may also serve the corporation in any other capacity and receive compensation therefor in any form.

## ARTICLE XII

### Indemnification

The Board of Directors is hereby specifically authorized to make provisions for indemnification of directors, officers, employees and agents of the corporation to the full extent permitted by law,

## ARTICLE XIII

### Amendment

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, in the manner provided by law, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE XIV

Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

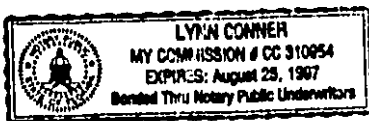
