ARTICLES OF INCORPORATION

The undersigned Incorporator for the purpose of forming a corporation under Chapter 607 Florida Statutes, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME AND ADDRESS

The name of this corporation is JOHN ISAAC DELGADO, M. D., P. A. The business mailing address of the corporation is Suite 103, 4021 North Armenia Avenue, Tampa, Florida 33607.

ARTICLE II - COMMENCEMENT OF EXISTENCE

This Corporation shall begin its existence at the time these Articles are subscribed to and acknowledged.

ARTICLE III - DURATION

The duration of the corporation is perpetual.

ARTICLE IV - SHARES OF STOCK

The aggregate number of shares which the corporation is authorized to issue is 5,000. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

ARTICLE IX - AMENDMENTS


