**ARTICLE 1. - NAME**

The name of the corporation is **BOULEVARD MANAGEMENT, INC.**

**ARTICLE 2. - PRINCIPAL OFFICE**

behalf of all officers and directors against any liability asserted against them or incurred by them in their capacity as officers and directors or arising out of their status as such.


