ARTICLE I - NAME

ARTICLE VIII - BY-LAWS

The undersigned, Keith Wasserstrom, the Incorporator of Knightsbridge of South Florida, Inc., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), the Articles of Incorporation of which were initially filed with the Department of State of the State of Florida on March 30, 1995, DOES HEREBY CERTIFY:

- 1. The name of this Corporation is KNIGHTSBRIDGE OF SOUTH FLORIDA, INC.
- 2. The Corporation's Articles of Incorporation are hereby amended as follows:
 - (a) Article VIII of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced by the following:

ARTICLE VIII - GOVERNANCE

- 3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
- 4. The Amendment hereby made to the Articles of Incorporation was duly adopted by a written consent executed by the Incorporator of the Corporation on May 15, 1995, pursuant to Section 607.0205 of the Florida Business Corporation Act. Shareholder action was not required.
