Article I - Name

The name of this corporation is MANOJ PATEL, P.A.

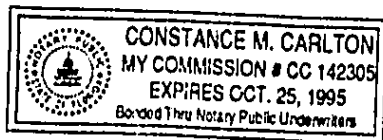


