ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is : THE WAVY CLIPPER, INC.

Article 2. Address of the principal office. The principal office and mailing address of the corporation is 101 Yacht Club Drive, St. Augustine, Florida 32095.

Article 3. Purpose. The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

Article 4. Capital Stock. The aggregate number of shares which the Corporation is authorized to issue is One Thousand (1,000) shares of common stock. Such shares shall be of a single class and shall have a par value of One (\$1.00) Dollar per share.

Article 5. Initial Registered Office and Agent. The street address of the initial Registered Office of the Corporation is 100 Southpark Blvd., Suite 407, St. Augustine, Florida 32086, and the name of its initial Registered Agent at that address is CLARK SCHAFFER.

Article 6. Initial Board of Directors. The number of Directors constituting the initial Board of Directors is one (1). The number of Directors may be increased or decreased from time to time in accordance with the By-laws but shall never be less than one. 



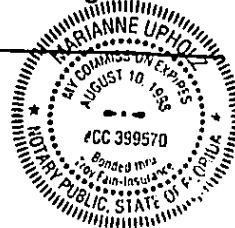
