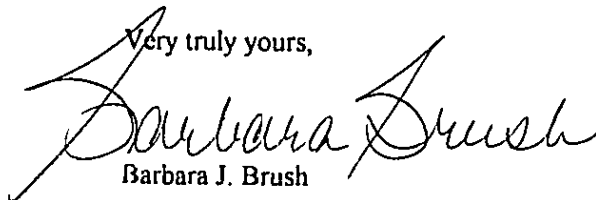

ARTICLE IV - CAPITAL STOCK

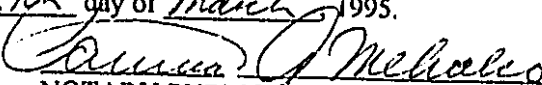
This Corporation is authorized to issue One Thousand (1000) shares of \$ 1.00 Par Value Common Stock.

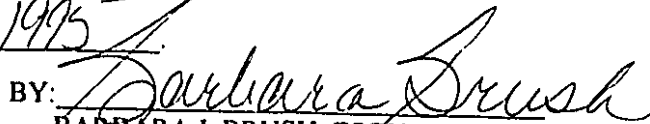

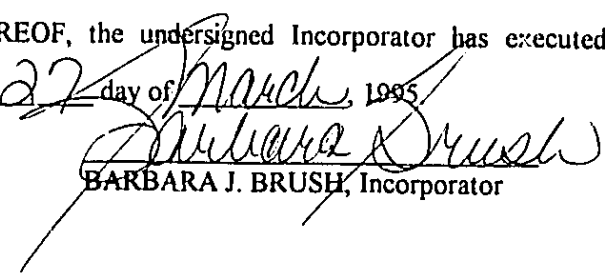
