ARTICLE I - NAME

The name of this Corporation is Susan E. Barnes, P.A. and its address is 227 S. Orlando Avenue, Suite B, Winter Park, Florida 32789.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This Corporation has been organized as a "professional service corporation" for the rendition of legal services pursuant to Chapter 621 of the Florida Statutes. The nature of the business of the corporation shall be to render professional legal services to the public, and, in connection therewith, to perform all acts and provide all services which are normally and customarily performed and provided by attorneys-at-law admitted to practice in the State of Florida. It is also intended that the corporation may own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, may invest in, trade in, deal in and with, products, goods, wares, and merchandise, real and personal property, and services of every kind, class, and description, and, in, general, may conduct and transact any and all business activities to the extent not prohibited to a professional legal services corporation by the

Florida Professional Service Corporation Act and other laws, rules, and regulations applicable to the corporation and its professional business.

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue 1,000 shares of ONE DOLLAR (\$1.00) dollar par value common stock, which shall be designated "Common Shares."

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The name of the initial registered agent of this Corporation is Susan E. Barnes, Esq. and her address is 227 S. Orlando Avenue, Suite B, Winter Park, Florida 32789.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

This Corporation shall have one (1) Director initially. The number of Directors may be increased or decreased from time to time by the Bylaws but shall never be less than one (1). The name and address of the initial Director of this Corporation is:

The Bylaws of this Corporation may be adopted, altered, amended or repealed by either the Shareholders or Directors.

ARTICLE VIII - INDEMNIFICATION

This Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the fullest extent permitted by law.

ARTICLE IX - PREEMPTIVE RIGHTS
