#### ARTICLES OF INCORPORATION

OF

J.R. AKIN & COMPANY, INC.

EFFECTIVE DATE

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

### ARTICLE I (Name)

The name of the corporation ("Corporation") is J.R. AKIN & COMPANY, INC.

### ARTICLE II (Duration)

The existence of the Corporation shall begin on April 1, 1995.

# ARTICLE III (Address)

### ARTICLE IV (Capital Stock)

The maximum number of shares this Corporation is authorized to issue is 1,000, all of which shall be common stock with a par value of \$1.00 per share.
