# ARTICLES OF INCORPORATION OF HEALTH-RITE DISCOUNT PHARMACY, INC.

We, the undersigned, hereby make, subscribe and acknowledge and this certificate for the purpose of becoming a corporation under the laws of the State of Florida.

#### ARTICLE I - NAME

The name of the corporation is HEALTH-RITE DISCOUNT PHARMACY, INC.

#### ARTICLE II - NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and of this State.
