ARTICLES OF INCORPORATION

OF

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be:

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this corporation shall be 201 West University Avenue, Gainesville, Florida 32601, and the mailing address shall be the same.

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares with a par value of \$.01 per share.


