The undersigned incorporators make, subscribe, acknowledge, and file with the Department of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I: NAME

The name of this Corporation is **I.D. Kiser, Inc.** with principal office and mailing address of 4843 Dunbarton Drive, Orlando, FL 32817.

ARTICLE II: TERMS OF EXISTENCE

This Corporation shall commence as of March 25, 1995 and shall have perpetual existence.
