ARTICLES OF INCORPORATION

OF

The undersigned, acting as Incorporator of a corporation under the Plorida General Corporation Act, adopts the following Articles of Incorporation of such Corporation:

ARTICLE I

The name of the corporation shall be Total Aviation Services,

ARTICLE II DURATION

The corporate existence shall begin at the time of subscription and acknowledgment of these Articles, except that in the event those Articles are not filed with the Department of State within five (5) days, exclusive of legal holidays, after subscription and acknowledgment hereof, corporate existence shall begin when these Articles are filed with the Department of State. This Corporation shall exist perpetually, unless sooner dissolved according to law.

ARTICLE III PURPOSE

The purpose for which the Corporation is organized is to ongage in any activity or business permitted under the Laws of the United States and of the State of Florida.

ARTICLE IV CAPITAL STOCK

The Corporation is authorised to issue Seven Thousand Five Hundred (7,500) shares of One Dollar (\$1.00) par value common

ARTICLE VIII PREEMPTIVE RIGHTS

ARTICLE IX CUMULATIVE VOTING

At each election for Directors, every Shareholder entitled to vote in the election shall have the right to cumulate his vote by giving one candidate as many votes as the number of Directors at that time multiplied by the number of his shares, or by distributing the votes on the same principle among any number of the candidates.

ARTICLE X INDEMNIFICATION

The Corporation shall indemnify any Officer or Director, or any former Officer or Director to the full extent permitted by law.

ARTICLE XI AMENDMENT

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any Amendment to them, and any right conferred upon the Shareholders is subject to this reservation.
