ARTICLE IX - PREEMPTIVE RIGHTS

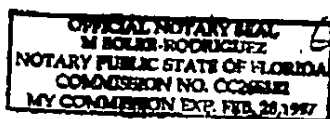

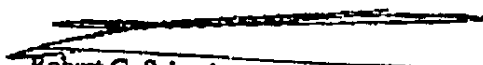
