The undersigned hereby form a Corporation under the following Charter of Articles of Incorporation:

ARTICLE I

The name of this Corporation shall be Suncoast Interior Textures, Inc.





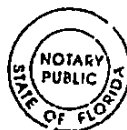
