**ARTICLES OF INCORPORATION
OF
ATLANTIS MARINE WELDING, INC.
(A Profit Domestic Corporation)**

These Articles of Incorporation are signed by the incorporator for the purpose of forming a profit corporation pursuant to Chapter 607 of Florida Statutes as follows:

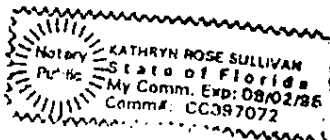
