ARTICLES OF INCORPORATION  
OF

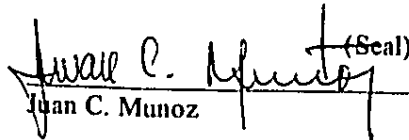
**ARTICLE X**

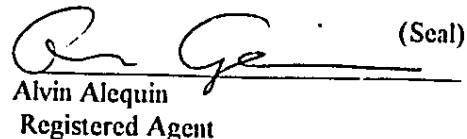
**ARTICLE XI**

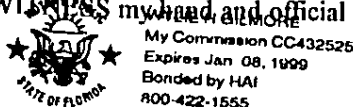

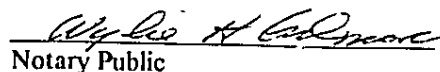
