**ARTICLES OF INCORPORATION
OF
THANK YOU, COME AGAIN, INC.**

Article I

Name. The name of this Corporation is THANK YOU, COME AGAIN, INC.

Article II

Initial Registered Office and Agent. The street address of the initial office of this Corporation is 2937-A Northeast 19th Drive, Gainesville, Alachua County, Florida, 32609 and the name of the initial registered agent of this Corporation is STEVEN T. GLADIN.

Article III

Capital Stock. This Corporation is authorized to issue 25 shares of One Dollar (\$1.00) par value common stock. All shareholders shall have preemptive rights in future stock sales by the corporation.

Article IV

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

Article V

Purpose. The purpose of this Corporation is to engage in any activities or businesses permitted under the laws of the United States and under the Florida Business Corporation Act.

Article VI

By-Laws. The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and Shareholders.

Article VII

The number of Directors may either be increased or diminished from time to time by the By-Laws, but it shall never be less than one. Article VIII


