ARTICLE I - NAME

The name of this Corporation is LEE & CATES KINGS BAY GLASS, EFFECTIVE DATE

ARTICLE II - NATURE OF BUSINESS

APR 1 1995

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III - CAPITAL STOCK

The authorized capital of the Corporation shall be ten thousand (10,000) shares of the common stock at a par value of One Dollar (\$1.00) per share.

ARTICLE IV - TERM OF EXISTENCE

This Corporation is to exist perpetually.
