My name is Glenn Martyn and I am President of Thrill Seeking, Inc.. In March of 1995 I formed my corporation mainly to protect my concept "Thrill Seeking Threads" from being stolen from a certain company at the time. Once I obtained control as a corporation and a registered trademark on my ideas, I've spent most of the last year researching the fashion industry and investing time and money into this concept without earning a profit. Since I have incorporated, I've moved addresses a few times, yet finally received an investment. We have recently obtained a CPA to organize and file our taxes for \$500.00. Our CPA, Bill Williams at phone # (813) 347-0242, told us that everything was taken care of and had me sign the 1996 Profit Corporation Annual Report, and to have it Post Marked by September 16, 1996 and it would not be late. Then I received a letter from the Florida Department of State, stating our payment and form was received but are being returned because:

"Our corporation was administratively dissolved or its certificate of authority was revoked for failure to file its 1996 corporate annual report form in a timely manner." I immediately called the Division of Corporation and spoke with Mr. Samy Caldwell on Monday, October 7, 1996 at 4p.m. eastern time. He told me that a letter of notification to be dissolved was sent to us, yet neither I nor my CPA have ever received such a letter. I explained to Mr. Caldwell that I am a designer and have never been incorporated before and my accountant who I just spent \$500.00 on took care of my taxes. Mr. Caldwell then told me since I did not receive the letter of notification to be dissolved and I am a new company to write this letter and send my Profit Corporation Annual Report along with a check for \$225.00 and he would dismiss all late and reinstatement fees this time only.

I'm just getting started and will be prepared in the future.
