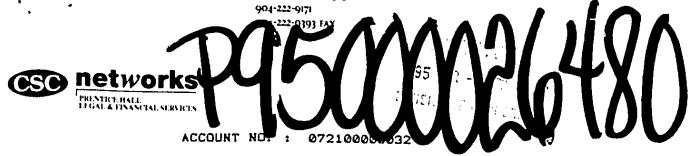

ARTICLES OF INCORPORATION OF DOB, INC.

The undersigned, for purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the follow-4 ing Articles of Incorporation:

ARTICLE ONE

The name of the corporation is DOB, INC.

EFFECTIVE DATE

ARTICLE TWO

The principal place of business and street address of this corporation is:

ARTICLE THREE

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is March 31, 1995 at 12:01 A.M.

ARTICLE FOUR

The general purposes for which the corporation is organized are:

- (1) To transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act, and to do all things lawfully permited under said act.
- (2) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
