The undersigned, for purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is DOB, INC.

ARTICLE THREE

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is March 31, 1995 at 12:01 A.M.

ARTICLE FOUR

The general purposes for which the corporation is organized are:

(1) To transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act, and to do all things lawfully permitted under said act.

(2) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.



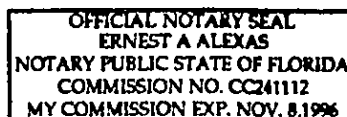

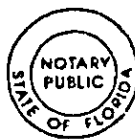
