ARTICLE I NAME:

The name of this corporation is:

No contract or other transaction between this corporation and any other corporation, and no act of this corporation shall in any way be affected or invalidated by the fact that any of the directors of the corporation are pecuniary or otherwise interested in or are directors or officers of such other corporation, any director individually, or any firm of which any director may be a member, may be party to, or may be pecuniarily or otherwise interested in, any contract or transaction of the corporation, provided that the fact that he or such firm so interested shall be disclosed or shall have

been known to the Board of Directors or such members thereof as shall be present at any meeting of the Board at which action upon any such or transaction shall be taken, and any director of the corporation who is also a director of such other corporation is so interested may be counted in deterring the existence of a quorum at any meeting of the Board of Directors of the corporation which shall authorize any such contract of transaction, and may vote therat to authorize any such contract or transaction with like force and effect as if he were not such director or officer of such other corporation or not so interested.

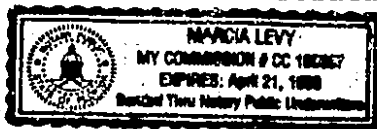
