ARTICLES OF INCORPORATION

OF

HARDEE COUNTY TITLE & ABSTRACT COMPANY

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is HARDEE COUNTY TITLE & ABSTRACT COMPANY.

ARTICLE II - DURATION

The duration of the corporation is perpetual.
