ARTICLE I-Name

The name of this corporation is LIFESTYLES EXCHANGE SERVICE, INC.

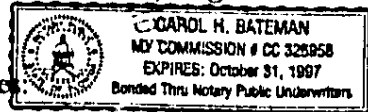
