Name

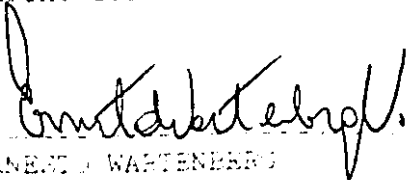
