ARTICLE I. NAME

The name of this corporation shall be Rebecca P. Campbell, P.A.

ARTICLE II. DURATION

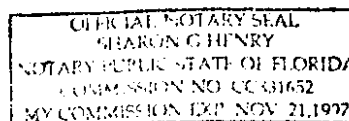
