ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this Corporation is **Top Cat Roofing, Inc.**

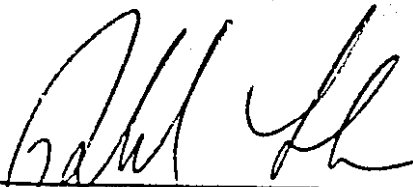

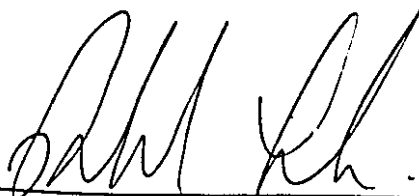
