

ARTICLES OF INCORPORATION

OF

TOP CAT ROOFING, INC.

ARTICLE I - NAME

The name of this Corporation is Top Cat Roofing, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

ARTICLE III - PURPOSES

This Corporation is organized to include the transaction of any or all lawful business for which Corporations may be Incorporated under Chapter 607, Florida Statutes (1975) as presently enacted and as it may be amended from time to time.

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue 500 Shares of \$1.00 par value common stock, which shall be designated as "Common Shares".

ARTICLE V - PREEMPTIVE RIGHTS
