

The undersigned acting as incorporators of a corporation under the Florida General Corporation Act hereby adopt the following articles of incorporation:

ARTICLE I

The name of the corporation is ALLY PEER, INC..

ARTICLE II

The period of its duration is perpetual.

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

ARTICLE IV

The aggregate number of shares that the corporation has authority to issue is 100, all of which shall be common shares with par value of \$1.00.




