ARTICLE I



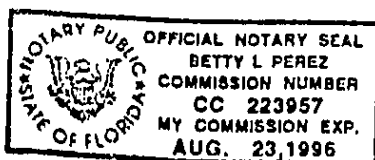
