ARTICLE I - NAME

The name of this corporation is:

ARTICLE II . DURATION

This corporation is to exist perpetually and it shall commence its existence as of the date of subscription and acknowledgement, provided such date is within 5 days from the date of filing, on the date of filing.

ARTICLE III - PURPOSE
