


ARTICLES OF INCORPORATION

OF

MINI-LIMES OF CORAL SPRINGS, INC.

The undersigned, subscribers to those Articles of Incorporation, natural porsons, computent to contract, horeby form a corporation under the laws of the State of Florida.

ARTICLE I XXXE

ARTICLE IV

. This corporation shall commence on the date of filing and shall have perpetual existence.

ARTICLE V REGISTERED AGENT AND REGISTERED OFFICE

ARTICLE VIII SPECIAL PROVISION

Any action by the Directors of this corporation which is within their power taken at a meeting of such Directors shall be valid for all intents and purposes whether or not lawful notice of said meeting shall have been given to all Directors as required by law or by the Dy-Laws of this corporation, if at anytime prior to, during, or subsequent to such meeting all Directors shall execute a waiver of notice of such meeting, in writing, and providing a majority of the Directors shall have approved or approve the action taken at much mooting.

When not prohibited by law, any action by the shareholders of this corporation which is within their power taken at a meeting of such shareholders shall be valid for all intents and purposes whether or not lawful notice of such meeting shall have been given to all shareholders as required by law or in the By-Laws of this corporation, if at any time prior to, during, or subsequent to such meeting all shareholders shall execute a waiver of notice of such meeting, in writing, and providing a majority of the chareholders shall have approved or approve the action taken at such meeting.
