ARTICLES OF INCORPORATION

A Florida Corporation

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a Corporation for profit under the Laws of the State of Florida.

#### ARTICLE I

The name of the Corporation is: TURNER CONSTRUCTION OF ORLANDO, INC.

#### ARTICLE II

This Corporation is to exist perpetually unless dissolved in accordance with the Laws of the State of Florida.

#### ARTICLE III

This Corporation may engage in any activities of business permitted under the Laws of the United States and of this State.

#### ARTICLE IV

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 100 shares of common stock at One Dollar (\$1.00) par value.
