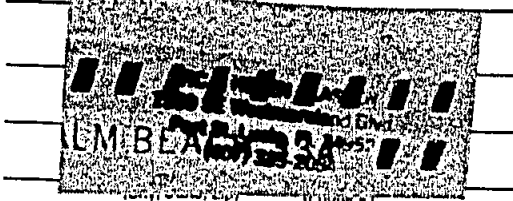

6. Existence.


