Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of this Corporation is Scott's Tile, Inc.
2. Paragraph FIRST of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

"FIRST: The name of this Corporation is:

**DECORATIVE TECHNOLOGIES, INC."**

3. The foregoing amendment was approved by the Board of Directors of the Corporation by Unanimous Written Consent on March 27, 2003, and it was recommended that the Articles of Amendment be presented to the Shareholders for adoption at a special meeting.
