# ARTICLES OF INCORPORATION OF CHANNEL 55 OF MILWAUKEE, INC.

The undersigned, acting as incorporator of Channel 55 of Milwaukee, Inc., under the Alexandre Florida Business Corporation Act, adopts the following Articles of Incorporation.

#### ARTICLE I. NAME
