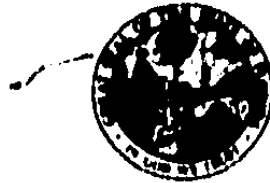

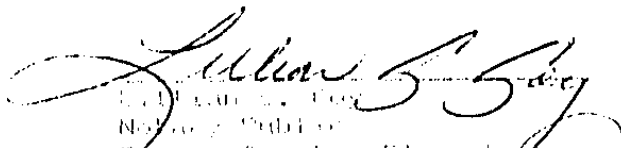

The aggregate number of shares of the corporation shall be 10,000 shares of \$10.00 each. The shares shall have a par value of \$1.00.

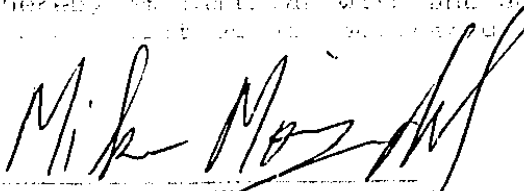
