ARTICLES OF INCORPORATION
OF

AFFORDABLE PAVING CONTRACTORS, INC.

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida Corporation Act, does hereby adopt the following articles of incorporation.

ARTICLE I

NAME

The name of the corporation is AFFORDABLE PAVING CONTRACTORS, INC.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

PURPOSE

The general purposes for which the corporation is organized are:

1. To act as a paving contractor for the construction, paving and repairing of pavements of all kinds, and for the improvement of real estate, and the doing of any and all other business and contracting incidental thereto, or connected therewith, and the doing and performing of any and all acts or things necessary, proper, or convenient for or incidental to the furtherance of carrying out the powers and purposes herein mentioned.

2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade business which can, at the option of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE IV

CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue is One Hundred (100) shares, Class A Stock, the par value is \$1.00 per share.

ARTICLE V

INITIAL REGISTERED OFFICE AND AGENT


