**KNOW ALL MEN BY THESE PRESENT:** That the undersigned incorporator does hereby incorporate a corporation under the provisions of Chapter 607, Florida Statutes, for the transaction of business with and under the following Articles of Incorporation:

**ARTICLE I**

**ARTICLE II**

The duration of the corporation shall be and is perpetual, and the date and time of the commencement of the corporation's existence shall be and is the date and time these Articles of Incorporation are filed by the Department of State of the State of Florida.

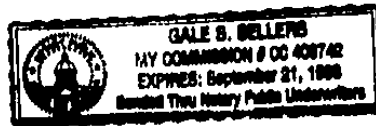

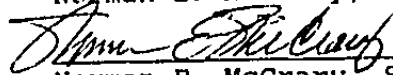
**FIRST:** The name of the Corporation is J. DANBLANC LEASING, INC.

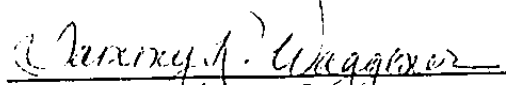

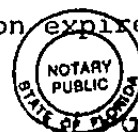
