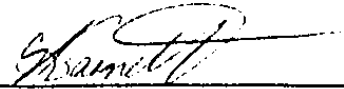

The undersigned, a natural person competent to contract, does hereby make, subscribe and file these Articles of Incorporation under the laws of the State of Florida.

**ARTICLE I
CORPORATE NAME**

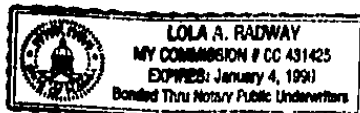

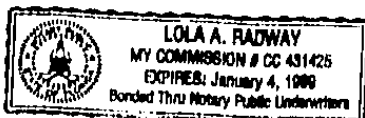
